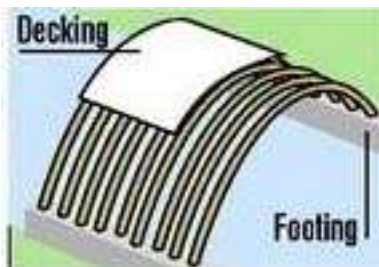

Bridge in a Backpack**

Bridge in a Backpack

It is called 'bridge in a backpack' because when the carbon fiber tubes are rolled up, they can fit inside a backpack. The technology was developed by the Advanced Structures and Composites Center at the University of Maine and is being implemented by a spinoff company, Advanced Infrastructure Technologies. See aitbridges.com.

Carbon fiber tubes are used as arches in the bridge. Using a special jig the tubes are shaped as needed for the application, inflated and treated with resin. This makes them strong enough to be moved in place on the new bridge footings. Once in place, the tubes are filled with concrete. The resin filled skins protect the concrete from weather and salt.

Once the concrete-filled arches are cured, they can be covered with decking and earth, and paved.

The main advantage of the technology is the dramatic reduction in construction time compared with more traditional bridge structures.

Power from the Panda**

Power from the Panda's Gut?

Fuel to power motor vehicles can be made from corn, but corn is a food that people can eat. So there is an ethical issue here. By turning huge quantities of corn into ethanol for motor vehicle use the price of corn is driven up. This puts pressure on the limited food budgets of many people, especially the world's poor.

Processes to generate ethanol from cellulose and lignin have been developed, but they are not very efficient or

economical. This led biochemist Ashli Brown at the Mississippi State University

to study the microbes in a panda's gut. As the panda's main diet is cellulose and lignin heavy bamboo, she figured the microbes in its gut must be able to convert cellulose and lignin into sugars the body can use. If she could identify the microbes involved, perhaps they could be used in an industrial process to convert cellulose and lignin to sugar, and then the sugar could be converted into alcohol.

Dr. Brown's team identified 17 microbes from the panda's gut capable of digesting cellulose and lignin, converting them into sugars readily fermented into ethanol or biodiesel. She is hoping to see this process be developed into one that's commercially viable.

Note: The Algonquin word for moose, loosely translated, means "twig-eater". Perhaps someone should check out their gut microbes, too!

**Book Review:
Is God a Moral Monster?
Reviewed by Ken Touryan**

The Book Review: *Is God a Moral Monster? Making Sense Out of the Old Testament God*. By Paul Copan, Baker Books, 2011, 252 pages \$11.48 paperback.

(I heard of Paul Copan through his brother, Walter Copan, while I was at the National Renewable Energy Lab, 2003-2006. We worked together in the Technology Transfer department).

Dr. Paul Copan is Chair of the Philosophy and Ethics Department at Palm Beach Atlantic University, FL. As Copan writes in his introduction (Chapter 1), he wanted to use the objections of the neo-atheists regarding the 'strange and harsh Old Testament laws' as a springboard to confront their accusations. The list Copan covers includes: the Canaanite 'genocide'; the binding of Isaac; a jealous, egocentric deity; racism; slavery; bride-price; women as inferior to men; and several others. A challenging task for anyone willing to tackle such a list!

The book is divided into four parts, with a total of 20 chapters, followed by discussion/study questions. The book ends with extensive notes and bibliography.

Copan devotes the first two chapters to explaining who the neo-atheists are and the specific arguments against the God of the Old Testament (OT) they bring to the discussion. Before starting his defense, he quotes various journalists and

philosophers of science who bemoan the simplistic arguments proposed by these atheists and their 'blustery rhetoric' as they attack religion. Copan is amazed that so many have been intellectually swindled by the neo-atheists' fallacious arguments.

The author starts each chapter by quoting a statement made by one of the neo-atheists on a topic that questions the morality of the OT God. For example, in Chapter 3 he answers Dennett's contention that God, by imparting His own image to mankind, demonstrates a 'proud God creating toys that look like him' and thus represent His vanity! Instead, Copan shows God's true humility towards his creatures as expressed in Isa 57:15, and the depth of deprivation God chose to go through (the cross) for their redemption.

It would be too lengthy to summarize Copan's comments for each of the 18 *specific issues* regarding how God (Yahweh) appears in the OT. Instead, I will give a few examples:

In Chapter 5, Copan addresses the accusation Dawkins makes about a God who would ask Abraham to sacrifice his one and only son. Dawkins considers this act to be tantamount to: "child abuse and bullying". In addition, Dawkins considers the crucifixion as child abuse. Copan responds to Dawkins by emphasizing the fact that OT actions, like that of Abraham sacrificing Isaac, have to be considered under a broader perspective, through the Good News itself. The story of Abraham and Isaac actually foreshadows God the Father, offering the redemptive sacrifice of the *second Isaac*, His one and only Son. He then presents the argument that in Christ's death on the cross we have no passive victim, but rather the predetermined plan of the triune God, where each suffered in the reconciling work; *something well known to us as part of the evangelical community*. [I attended an atheists of Denver meeting where a former Baptist minister, now declaring himself an atheist, described the redemptive death of Christ on the cross as God responsible for ordering the killing of his son!]

Copan employs the same types of argument in all the other chapters.

- 1- He relates events of the time, and commands given by Yahweh in the OT, *within the perspective* of God's eventual act of reconciliation through the Cross.

- 2- Another general argument Copan uses is that OT laws were not given in a vacuum. They presented a 'dramatic' moral improvement over pagan practices of the time, but at the same time reflected the ancient Near Eastern social context.
- 3- The Mosaic laws of conduct (other than the Ten Commandments) should not be dismissed glibly, but should not be universalized either.

In Chapter 9, the author tries to deal with the most 'egregious sounding' laws that seem barbaric and crude by our 21st century standards, such as stoning of the Sabbath-breakers and slanderers. Copan asks us to evaluate the severity of harsh laws and punishments *in their ancient Near Eastern context* instead of in light of Western culture. According to Copan, while Mosaic laws do not reflect the ultimate or the ideal, these laws and the mind-set they exhibit, reveal a dramatic moral improvement and greater moral sensitivity than their ancient Near Eastern counterparts.

Copan devotes three chapters to the killing of the Canaanites. He admits that the Yahweh-war texts do prove to be troubling and are the most 'weighty' of all OT ethical considerations and should not be glibly dismissed or ignored (and hence the three chapters he devotes to dealing with these 'sanctioned' war issues). One of his key arguments is that these war-like acts were given as a command by Yahweh in a specific time in history, for a very specific purpose and *were not to be universalized*. He then brings in the book of Job to remind us that the full picture of God's sovereignty is not available to us with our "worm's eye view" of most human events.'

It will be impossible for me to do justice to Copan's convoluted arguments in a synopsis, such as this. However, once again he invokes the 'big picture' by ending chapter 17 with these words: "Though a Canaanite-punishing God strikes us as incompatible with graciousness and compassion, we cannot escape a redeeming God who loves his enemies ... and allows himself to be crucified *by his enemies* in hopes of redeeming them. (Luke 23:34)."

Copan ends his book with two more chapters (19 and 20) where he develops the Divine foundation for goodness, and then presents Jesus' role in fulfilling the OT actions, laws and prophecies. He

concludes the book with God's ultimate act of reconciliation, i.e., that the loving, self-sacrificing God-man, in obedience to his Father has invited us to be reconciled with Him.

Copan's book can be used as a good reference volume, when confronted with such tough and knotty issues that appear in the OT.

Angels We Have Seen on High

After WW II, UFO sightings and ET incidents involving both the global public and world military powers began in earnest. The first was Navy-related, when tracking radar apparently interfered with an ET craft in 1941, causing a crash that was recovered by the Navy during the time of FDR. The first major events for the U.S. government (USG) for which there is significant information were the vehicle crashes at Roswell and Corona. In New Mexico, an ET scout craft split in two, crashing near Roswell. Another crash-landed near Corona, New Mexico with one survivor. The USG has recovered remains of subsequent ET vehicle crashes in ensuing years. Roswell was given a cover story by the USAF about weather balloons and then later, another about radar testing. Four bodies of what are now called "Greys" were recovered from the Roswell crash and taken through Ft. Riley to Wright-Patterson AFB in Dayton, Ohio, to the Foreign Technology Division and the legendary Hanger 18. (This is now Building 18 and is a hypersonic engine test facility.) One live alien was recovered and kept at Los Alamos for several years before he (a male flight technician) died. Ordinarily, Greys live 400 to 500 years. After distilling much that the Web offers on UFOs, what follows is some of what is left from the more credible sources.

In the 1960s, the idea of ancient visits by ETs was popularized in the work of Erich von Däniken and later by Zechariah Sitchin and others, writing on the premise that what scripture calls angels have left evidence in the past. Sitchin has been substantially discredited in his translational claims by ancient Near-East

scholar and theologian Michael S. Heiser (www.michaelsheiser.com), who also denies the "ancient astronaut" thesis of Sitchin. Although von Däniken's speculations about ancient-ET evidence have also been seriously questioned, the central thesis in *Chariots of the Gods?* is part of the disclosed view. Encounters with angels or gods are found throughout the Bible (OT and NT) and treated rather matter-of-factly, without any extraordinary aplomb. My view is that they are from the heavens and are ETs. While hints are given of their importance, angels remain in the background of the biblical narrative, appearing at important events such as the cutting of covenants, until they are given a central role in the last, apocalyptic writing where they are more than *messengers*. (The angels who warned Lot to flee Sodom blinded sexual perverts who assailed them, so they do more than deliver messages.) However, it was not until the mid-20th century that what was no revelation to Martin Luther began to make some significant sense. The '50s saw the first widespread popular attention given to unidentified flying object (UFOs) and thousands of sightings were reported to the U.S. Air Force (USAF) and other agencies of the USG.

The USAF Project Blue Book undertook to study these reports. By the time the project was ended in the late 1950s, investigation of UFOs was taken out of the USAF's hands (much to the consternation of some high-level USAF officers). The head of the project, Edward J. Ruppelt, wrote an Ace Book (G-537, 50 cents in 1956), *The Report on Unidentified Flying Objects*, popularizing the conclusion that, of the thousands of reported sightings, most were explainable as human or natural phenomena. In the forward of the book, Ruppelt gives the two reasons for why he wrote it: first, "there is a world-wide interest in flying saucers; people want to know the facts. But more often than not, these facts have been obscured by secrecy and confusion ..." and second, because of his key position of involvement in the project, giving him wide experience in talking to credible people - industrialists, pilots, engineers, generals, and "many very capable scientists". He further wrote:

The report has been difficult to write because it involves something that officially doesn't exist. It is well known that ever

since the first flying saucer was reported in June 1947 [near the time of the Roswell crash] the Air Force has officially said that there is no proof that such a thing as an interplanetary space ship exists. But what is not well known is that this conclusion is far from being unanimous among the military and their scientific advisers because of the one word, *proof*; so the UFO investigations continue.

Ruppelt concludes the forward by writing: "I'll give you the facts - all the facts - you decide." Of course, even Ruppelt did not have all the facts, and he also did not disclose the letter of General Nathan Twining (who later became head of the Joint Chiefs of Staff) or, for

instance, the following declassified Eisenhower briefing on the Roswell crash in 1947. (See www.majesticdocuments.com for more on these sources.) "Dr. Bush" is Vannevar Bush, who was a prominent scientist at MIT and was also chosen to head the above-top-secret committee controlling ET information, labeled MJ-12. One of the ironies of the memo is that Dr. Donald Menzel was a Harvard professor of astronomy who wrote popular-level books debunking UFOs and ETs. Menzel is listed with Bush among the names of the original MJ-12 group during the Truman administration.

Ruppelt's book was written at the end of a transitional time when the UFO issue was going deep undercover in the USG and

A covert analytical effort organized by Gen. Twining and Dr. Bush acting on the direct orders of the President, resulted in a preliminary consensus (19 September, 1947) that the disc was most likely a short range reconnaissance craft. This conclusion was based for the most part on the craft's size and the apparent lack of any identifiable provisioning. (See Attachment "D".) A similar analysis of the four dead occupants was arranged by Dr. Bronk. It was the tentative conclusion of this group (30 November, 1947) that although these creatures are human-like in appearance, the biological and evolutionary processes responsible for their development has apparently been quite different from those observed or postulated in homo-sapiens. Dr. Bronk's team has suggested the term "Extra-terrestrial Biological Entities", or "EBEs", he adopted as the standard term of reference for these creatures until such time as a more definitive designation can be agreed upon.

Since it is virtually certain that these craft do not originate in any country on earth, considerable speculation has centered around what their point of origin might be and how they get here. Mars was and remains a possibility, although some scientists, most notably Dr. Menzel, consider it more likely that we are dealing with beings from another solar system entirely.

Numerous examples of what appear to be a form of writing were found in the wreckage. Efforts to decipher these have remained largely unsuccessful. (See Attachment "E".) Equally unsuccessful have been efforts to determine the method of propulsion or the nature or method of transmission of the power source involved. Research along these lines has been complicated by the complete absence of identifiable wings, propellers, jets, or other conventional methods of propulsion and guidance, as well as a total lack of metallic wiring, vacuum tubes, or similar recognizable electronic components. (See Attachment "F".) It is assumed that the propulsion unit was completely destroyed by the explosion which caused the crash.

was taken away from the USAF and Navy. It is now in the hands of the Special Studies Group, what earlier was called MJ-12 (Majority or Majestic 12) within the National Security Council (NSC). One putative former member and leader of this group, Dr. Michael Wolf, disclosed significant information about USG involvement with ETs during his time of terminal cancer in the early 2000s. The disclosure was agreed to by the SSG. Other controlled leaks have occurred and they essentially corroborate what capable and credentialed UFOlogists have said, most of whom came out of backgrounds of covert USG "UFO" involvement. When an authentic leak occurs, counterintelligence goes to work to discredit the source. UFO investigators then must go to work to sort out the real intelligence from the noise. One example of a noise source, Bob Lazar, who worked in Area 51 of the Nevada Test Site as a technician, was identified by Stanton Friedman (www.stantonfriedman.com), who is perhaps the foremost investigator of UFO-ET questions.

For decades, there has been ambivalence within this highly-secretive group about whether the existence of ETs should be disclosed to the general public and how much of the subsequent *exopolitics* should be made known. USG interaction, including agreements, with various forms of ETs over the intervening decades has complicated disclosure with a substantial history that would need to be recounted for a full picture. This history is compartmentalized with various clearances, as can be noted in the leaked transcription of the ET briefing of Reagan conducted by CIA director Bill Casey. (Look under Reagan at www.presidentialufo.org.)

US Flying Saucers

Funding for multiple Manhattan-sized ET-related technology projects have purportedly been ongoing. Ever wonder how the Pentagon could just happen to lose (as was reported in the mainstream news) a trillion (not billion) dollars in their accounting, and without major GAO investigation? Also, by keeping drugs illegal, the CIA maintains a near-monopoly on the world-wide drug trade. The huge profits from these *black-ops* also disappear into secret projects.

Another incongruity in late 20th century technological history is why something as important as space has been

left to languish with the demise of the Space Shuttle program. An aggressive U.S., with a power elite intent on establishing a global hegemonic order, would certainly not omit taking the high ground of space. They have not. The public and civilian aspect of NASA has been left to mow the lawns at NASA facilities while the undisclosed aspects (including several classified Shuttle missions) are directed toward the advanced, undisclosed technology. Most of this is not under NASA but is military and is highly compartmentalized. Some of the German- or ET-derived technology (and there are arguments about sources) is operational in disclosed weapons such as the B-2 bomber. It has a different mode of flight when airborne and is known to have a high-voltage system, not unlike the electrogravitic demonstrator that Thomas Townsend Brown showed the U.S. military, shortly after which he and his work also disappeared.

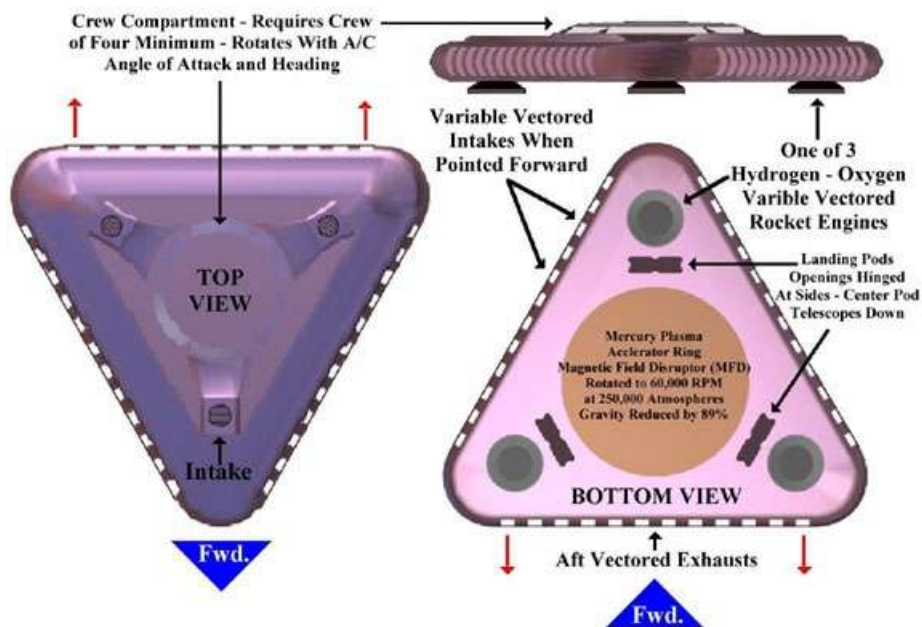
Shown below is a diagram of one of the advanced-propulsion vehicles flown out of the Nevada Test Site. It looks like the triangular crafts that were observed by hundreds of people during a sighting in Belgium that was brushed off officially as

"mass hallucination". The existence of these drawings shows either successful counterintelligence work or, more likely, that with such large projects it is not possible to maintain absolute secrecy.

Reverse engineering of the recovered technology with ET aid has led to undisclosed single-stage-to-orbit craft such as this giant triangular, 600 foot nuclear-powered TR-3B Astra, which is capable of going to the moon and returning when fitted with extra LOX tanks. The three methane-LOX rocket engines at the vertices of the vehicle do the lifting and propulsion. The description and drawing shown above was depicted by Edgar Fouche, who worked on several black-budget aerospace projects and is one of the disclosers.

The TR-3B base of operations has been moved from the Pappoose Lake (S-4) area (south of Groom Lake at Nellis AFB, Nevada) to a more secretive location in Utah; the Nevada Test Site is too much noticed nowadays. The key sci-fi-like technology from Roswell that has been reverse-engineered is putatively magnetogravitic, and in the TR-3B is able to null out 89 % of the gravity (mass) within the field generated by the

USAF Top Secret Nuclear Powered Flying Triangle - The TR-3B



magnetogravitic device. This is the same kind of technology that the NAZIs were experimenting with under Hans Kammler in the NAZI "Bell". Mercury vapor pressurized to 250,000 atmospheres and at 150 Kelvin is rotated at 50,000 rpm to produce a superconducting plasma with a strong magnetic field. In the early 20th century, Tesla had suggested, and Einstein hypothesized from the General Theory of Relativity, that with a sufficiently strong electric or magnetic field, gravity would be affected.

Don't ask me how it works; apparently the key discovery - one that Nikola Tesla proposed (and is often credited to Einstein because he was at the Princeton Institute for Advanced Studies where Tesla proposed it) resulted in *The Philadelphia Experiment*, the title of yet another sci-fi movie. The Philadelphia Experiment is covered at some length on the Internet and remains officially undisclosed to this day, probably because what was involved is related to electrogravitic or magnetogravitic effects.

Leaked Documents

A USG document with procedures for recovery of ET crashes was leaked in the mid 2000s. A couple of pages are shown at right of the Special Operations Manual. This document raises the question of whether it is credible to believe that the USG can hold a secret of this magnitude for decades. While those from within the covert world who have addressed this question answer it in the affirmative, the answer appears to be: yes and no. It is possible, with successful counterintelligence, to suppress a major secret for a long time, but it is not possible to contain every important leak. Consequently, with some work it is possible to cut through the misinformation and outright blather on the topic and identify the credible researchers and disclosers. Most of them come from an involvement in ET covert work. Others are seasoned investigators of non-mainstream topics, such as engineering professor Jim Marrs, who has written a book, *Alien Invasion* on the topic of ETs on the planet and what they are doing here. While the affairs of some ETs are not quite (but almost) as invasive and sinister as in the movie classic, *Invasion of the Body Snatchers*, the interactions of the USG with ETs generally is complex and has resulted in compartmentalized secrets.

**CHAPTER 1
OPERATION MAJESTIC-12**

Section I. PROJECT PURPOSE AND GOALS

1. Scope

This manual has been prepared especially for Majestic-12 units. Its purpose is to present all aspects of Majestic-12 so authorized personnel will have a better understanding of the goals of the Group, be able to more expertly deal with Unidentified Flying Objects, Extraterrestrial Technology and Entities, and increase the efficiency of future operations.

2. General

MJ-12 takes the subject of UFOBs, Extraterrestrial Technology, and Extraterrestrial Biological Entities very seriously and considers the entire subject to be a matter of the very highest national security. For that reason everything relating to the subject has been assigned the very highest security classification. Three main points will be covered in this section.

- a. The general aspects of MJ-12 to clear up any misconceptions that anyone may have.
- b. The importance of the operations.
- c. The need for absolute secrecy in all phases of operation.

3. Security Classification

All information relating to MJ-12 has been classified MAJIC EYES ONLY and carries a security level 2 points above that of Top Secret. The reason for this has to do with the consequences that may arise not only from the impact upon the public should the existence of such matters become general knowledge, but also the danger of having such advanced technology as has been recovered by the Air Force fall into the hands of unfriendly foreign powers. No information is released to the public press and the official government position is that no special group such as MJ-12 exists.

4. History of the Group

Operation Majestic-12 was established by special classified presidential order on 24 September 1947 at the recommendation of Secretary of Defense James V. Forrestal and Dr. Vannevar Bush, Chairman of the Joint Research and Development Board. Operations are carried out under a Top Secret Research and Development - Intelligence Group directly responsible only to the President of the United States. The goals of the MJ-12 Group

When President Reagan was briefed (as taken from the controlled-leak transcript), some questions he asked Bill Casey (then CIA chief) could not be addressed without a reassessment of the clearances of those in attendance at the briefing. UFO researcher Grant Cameron's website www.presidentialufo.com goes through the documentation on the U.S. presidents and the subject-matter, beginning with FDR. Truman was the first President to personally be in the presence of a live ET. Eisenhower was the first to reject an agreement (technology for nuclear disarmament) by a group of non-interfering ETs. Subsequently, an agreement was made (with Greys at Holloman AFB) for advanced technology in exchange for the freedom by Greys to do research on humans (through abductions). At their stage of advancement, the things we value - gold, oil, integrated circuits - are replaced by genetic information. Some Presidents (Kennedy, Carter, and Clinton), when briefed on ETs, thought the American public should be informed.

The quick emergence after WW II and during the '50s of UFOs was, according to leaked accounts from ETs, a result of the emergence of human technology into the nuclear age. With the explosion of the atomic bomb, otherworldly visitors began to take special notice of humanity. The emergence into space also has heightened their interest in us. Several astronauts have commented on their observation of intelligently guided UFOs near their spacecraft in orbit, or have given strong hints of it. The reclusive Neil Armstrong and Edwin "Buzz" Aldrin are included, along with Edgar Mitchell, Gordon Cooper, Jim Irwin, and others. NASA has participated in the hush-up.

Underworld Technology

One of the questions that arises when considering the conjecture that advanced technology has been kept secret for decades is where it is kept and developed. The Germans pioneered extensive underground tunneling and facility-building, continued after WW II by the Americans. It is another largely undisclosed technology. The Germans had facilities about 150 feet beneath the ground surface. Author R. A. Harbinson wrote:

Regarding the possibility of the Germans building self-sufficient underground research factories in the Antarctic, it has only to be pointed out that the underground research centers of Nazi Germany were gigantic feats of construction, containing wind tunnels, machine shops, assembly plants, launching pads, supply dumps and accommodation for all who worked there, including adjoining camps for slaves - and yet very few people knew that they existed.

U.S. underground operations are also far more extensive than is generally known. Dr. Richard Sauder has made it a personal quest to investigate secret underground facilities. Tunneling technology has advanced far beyond where the NAZIs took it, with their large multistory structures 150 feet below ground. According to Sauder, depths have now advanced to as much as 12 miles.

Shown below is the Subterrene 1 and a photo of a lesser tunneling machine. The larger machine is said to be nuclear-powered. Sauder reports that



transcontinental tunnels exist and also tunnels between the Nevada Test Site and major southern California aerospace companies.

Mystery Babylon and Technology

Both advanced attack and freighter-sized U-boats with the superior technology of the Third Reich disappeared at the end of WW II. Where most of these submarines went is a mystery. Two U-boats that surrendered in Argentina about a year later were of the advanced types but were not the freighter-sized U-boats used to supply the wolf packs. They were last seen having their armaments unloaded in Kiel or Bremen and resupplied with other items. None of them is accounted for today. The second of two huge Junkers airplanes in Norway that were intended to deliver the atomic bomb to New York also disappeared. Even more significantly, 8 of the 9 advanced NAZI research sites under Hans Kammler disappeared. Where did they go?

In the Ukraine, a strange procession of uniformed Aryan mädchens, selected by the SS from among the Germanic residents of the Ukraine, boarded a train to be trained in how to live in an arctic environment as prospective wives of selected SS men. Where was Hans Kammler and 250,000 other Germans who could not be accounted for after the war? Did they indeed defeat Admiral Byrd in Antarctica? In the last decade, a NAZI redoubt in Chile came to the attention of Japanese reporters who attempted to investigate. It is a fascinating story (though not for this article).

In reflecting upon NAZI technical accomplishments and aspirations, Joseph Farrell concludes *Reich of the Black Sun* wondering whether the openness of the scientific tradition, as carried over into technology, will degenerate into something like the Babylonian mystery religion, a "two-tiered" science, one for the public, and one for the priests:

There is a degree of evidence that this is, in fact, what happened in ancient times, and certainly it seems to have happened to the Kammlerstab's work after the war.

Perhaps, at least initially, its contents were so sensational that, for moral reasons, it was decided to keep it under wraps. But the Will to Power remains closeted within that science and the black projects it engendered and no doubt continues to engender.

While the 60-year deliberation about how much should be told the public about ETs continues, the information largely remains above top secret. The many observable indicators of the Will to Power among the international power elite leads me to believe that the ET card will not be played until it has some power-grabbing benefit - like perhaps a false return of the Messiah or a space attack on an earth governed by a false Messiah. The *Revelation* account of Christ's return is accompanied by talk that could refer to underground facilities (Rev. 6:15-16, ESV):

Then the kings of the earth and the great ones and the generals and the rich and the powerful, and everyone, slave and free, hid themselves in the caves and among the rocks of the mountains, [16] calling to the mountains and rocks, "Fall on us and hide us from the face of him who is seated on the throne, and from the wrath of the Lamb, ..."

According to Strong's dictionary of Greek words, "fall" (*pipto*) suggests a possible reading of "to alight" - or in this context, to close over, to seal the tunnels. Perhaps the ancient emphasis on the underworld as one of the three levels of the cosmos takes on new meaning in the tunneling context as does the upper level, the first heaven or troposphere. The ancient view of the solidity of the sky also makes more sense when considered from the standpoint of a re-entry vehicle at high velocity.

Although an article purporting to survey what is generally undisclosed is readily subject to doubt and criticism, I offer these hypotheses and facts, or putative facts, for your consideration as you ponder the larger possibilities that exist around us and their consequences for history and for the future of us Adamites.
